MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(SIPARIA KI MAI CELEBRATIONS) ORDER, 2016

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Ki Mai Celebrations) Order, 2016.

2. This Order shall commence on Wednesday 23rd March, 2016 at Duration 4.00 p.m. and expire on Friday 25th March, 2016 at 2.00 p.m.

3. Vehicular traffic and parking are prohibited on—

- (a) George Street, between Coora Road and La Pastora Street;
- (b) Mary Street, between Coora Road and La Pastora Street;
- (c) Station Street, between Mary Street and Victoria Street;
- (d) Edward Street, between Mary Street and Siparia-Erin Road;
- (e) Cemetery Street, between La Pastora Street and Clara Gregory Street; and
- (f) La Pastora Street, between Victoria Street and Siparia-Erin Road.

4. (1) Parking is prohibited between the hours of 4.00 p.m. on Wednesday 23rd March, 2016 and 2.00 p.m. on Friday 25th March, 2016 on—

- (a) Coora Road, between Siparia-Erin Road and Victoria Street; and
- (b) Victoria Street, between Coora Road and La Pastora Street.

(2) Parking is prohibited between the hours of 2.00 p.m. on Thursday 24th March, 2016 and 2.00 p.m. on Friday 25th March, 2016 on—

- (a) De Gannes Lane;
- (b) Siparia Road, between Potters Lane and Siparia-Erin Road;
- (c) Grell Street; and
- (d) Gambal Street.

Traffic routes      5. Between 2.00 p.m. on Thursday 24th March, 2016 and 2.00 p.m. on Friday 25th March, 2016 vehicular traffic approaching Siparia from—

- (a) Erin, along the San Fernando-Siparia-Erin Road and proceeding to San Fernando, shall proceed north onto Siparia Road, east onto Gambal Street, south onto Grell Street and east onto the San Fernando-Siparia-Erin Road;
- (b) Fyzabad, along Siparia Road, shall proceed east onto De Gannes Lane, south onto Potter Lane and back onto the Siparia Road; and
- (c) Penal, along the San Fernando-Siparia-Erin Road, shall proceed north along Grell Street, onto Gambal Street and onto Siparia Road.

Taxi stands          6. (1) The Erin Taxi Stand shall be relocated to the entrance of the Siparia Market.

(2) The Penal Taxi Stand shall be relocated to the western side of Bermudez Street and the junction of the San Fernando-Siparia-Erin-Road.

Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by a member of the Police Service and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
