MADE BY THE MINISTER OF WORKS AND TRANSPORT UNDER SECTION 65 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE MISCELLANEOUS ROAD TRAFFIC (AMENDMENT) ORDER, 2016

1. This Order may be cited as the Miscellaneous Road Traffic Citation (Amendment) Order, 2016.

2. The Road Traffic (Prohibited Parking) Order is amended—

The Road Traffic (Prohibited Parking) Order Chap. 48:50 amended First Schedule Part G

(a) in Part G of the First Schedule by—

(i) inserting after item 5, the following item:

“5A. Zampty Lane, Belmont, in the City of Port-of-Spain.”; and

(ii) deleting both items numbered 45 and substituting the following items:

“45. Ethel Street, St. James, between Western Main Road and its intersection with Bay Road and Broad Street.

46. Western Main Road, between the entrance to Alcoa Steamship Company Incorporated and the entrance to the Cove.”; and

(b) in the Second Schedule, under the heading “County of St. George East” by inserting after item 4, the following item:

Second Schedule

5. Orange Grove Road, St. Augustine between Streatham Lodge Road and College Road. Monday to Friday between 6.00 a.m. and 9.00 a.m. and between 3.00 p.m. and 6.00 p.m. Public holidays not included”.

(a) inserting after item 10, the following item:

“10A. Duke Street, between Southern
St. Vincent Street and Edward Monday to
Street from a point nine metres Friday
west of St. Vincent Street and
extending to a point forty-
nine metres westwards, except
for persons driving official
motor vehicles of the Maritime
Services Division, Ministry of
Works and Transport.”; and

(b) inserting after item 44, the following item:

“45. Tranquillity Street, in the City of Southern
of Port-of-Spain.

5. The One-Way Traffic Order is amended in Part G by—

(a) inserting after item C 21, the following item:

“22. Hart Street, between St. Vincent Street and

Avenue and Prince Charles Avenue, between the
hours of 4.00 p.m. and 6.00 p.m., Monday to Friday,
except public holidays.”.

6. (1) Clauses 2, 3, 4(b) and 5 come into operation on Monday Commencement
25th April, 2016.

(2) Clause 4(b) comes into operation on Tuesday 14th June,
2016.
