REGULATIONS

MADE BY THE MINISTER OF NATIONAL SECURITY UNDER SECTION 244
OF THE DEFENCE ACT

THE DEFENCE (RATES OF PAY AND ALLOWANCES)
(AMENDMENT) (NO. 2) REGULATIONS, 2016

1. These Regulations may be cited as the Defence (Rates of Pay and Allowances) (Amendment) (No. 2) Regulations, 2016.

2. In these Regulations, “the Regulations” means the Defence (Rates of Pay and Allowances) Regulations, 1989.

Interpretation

3. The Regulations are amended in regulation 14, by revoking subregulation (4) and substituting the following subregulations:

Regulation 14
amended

“ (4) Where an officer or other rank is on duty, other than training, in a country other than Trinidad and Tobago, he is entitled to—

- (a) a subsistence allowance, at the rate set out in Part II of the Schedule;
- (b) a meal allowance, at the rate set out in Part II of the Schedule;
- (c) a flat allowance, at the rate set out in Part II of the Schedule; and
- (d) hotel accommodation at the rate of seventy-five per cent of the respective rate determined by the Minister of Finance in respect of official overseas travel.

(5) Where an officer or other rank is on training, in a country other than Trinidad and Tobago, he is entitled to a flat allowance and a subsistence allowance at the rate set out in Part II of the Schedule and the following allowances subject to the extent that the training or operations is sponsored by an external agency:

- (a) a meal allowance, at the rate set out in Part II of the Schedule;
- (b) hotel accommodation, at the rate of seventy-five per cent of the respective rate determined by the Minister of Finance in respect of official overseas travel; and
- (c) ground transportation, at the rate set out in Part II of the Schedule.”

4. The Regulations are amended in regulation 17—
- (a) in subregulation (1), by inserting after the word “allowance”, the words “, payable once every two years,”; and
- (b) in subregulation (4), by inserting after the word “allowance”, the words “, payable once every two years,”.
