THE CUSTOMS ACT, CHAP. 78:01

REGULATIONS

MADE BY THE PRESIDENT UNDER SECTION 263(1) OF THE CUSTOMS ACT

THE CUSTOMS (FEES) (AMENDMENT) REGULATIONS, 2016

1. These Regulations may be cited as the Customs (Fees) Citation
(Amendment) Regulations, 2016.

2. In these Regulations, “the Regulations” means the Customs Interpretation
(Fees) Regulations, 1957. G.N. No. 44
of 1957

3. Regulation 4 of the Regulations is amended— Regulation 4
amended

(a) in the chapeau, by deleting the words “the following
rates—” and substituting the following words:

“the rate of overtime fees set out in the Schedule—

(a) in respect of the class of Officers specified;
and

(b) with effect from the date specified.”; and

(b) by deleting paragraphs (a) to (h).

4. Regulation 4A of the Regulations is repealed and the following Regulation 4A

4A. Notwithstanding regulation 4, a person is exempt
from paying any increase of the rates of overtime fees
set out in the Schedule, if the increase comes into effect
as a result of an amendment to the Regulations that is

the duties.”.
