## A PROCLAMATION

WHEREAS it is provided by section 2 that the Family and Children Division Act, 2016 (hereinafter referred to as “the Act”) shall come into operation on such date as is fixed by the President by Proclamation:

And whereas it is expedient that the following provisions of the Act come into operation:

- (a) sections 1, 2, 3, 4(1), (3), (5), (6) and (7), 6(1) and (2), 7, 8, 10, 12, 16, 17, 18, 26, 28, 31, 32, 33, 60 and 61;
- (b) section 63 in so far as it relates to the provisions of Schedule 5 specified in paragraph (d);
- (c) Schedules 1 and 3; and
- (d) items 1, 2, 3, 4, 5(d)(ii), 6, 7, 9(a), (b), (c), (d), (e), (f) and (g), 10, 11, 12, 13, 14, 15(a)(i), (ii) and (iii), (b)(i) and (ii), (c), (d), (e), 16(a), (b), (c), (d), (e), (f), (g), (i), (j), 17(a)(i) and in (ii) the definitions of “child charged” and “child offender”, (c), (f), (g), (h), (i), (j), (m)(i) and (ii)(A), (n)(i)(A) and (ii), (o), (r), (ra), (s), (t), (u) and (v) of Schedule 5:

Now, therefore, I, ANTHONY THOMAS AQUINAS CARMONA, President as aforesaid, do hereby fix the 15th day of May, 2017 as the date on which the following provisions of the Act shall come into operation:

- (a) sections 1, 2, 3, 4(1), (3), (5), (6) and (7), 6(1) and (2), 7, 8, 10, 12, 16, 17, 18, 26, 28, 31, 32, 33, 60 and 61;
- (b) section 63 in so far as it relates to the provisions of Schedule 5 specified in paragraph (d);
- (c) Schedules 1 and 3; and
- (d) items 1, 2, 3, 4, 5(d)(ii), 6, 7, 9(a), (b), (c), (d), (e), (f) and (g), 10, 11, 12, 13, 14, 15(a)(i), (ii) and (iii), (b)(i) and (ii), (c), (d), (e), 16(a), (b), (c), (d), (e), (f), (g), (i), (j), 17(a)(i) and in (ii) the definitions of “child charged” and “child offender”, (c), (f), (g), (h), (i), (j), (m)(i) and (ii)(A), (n)(i)(A) and (ii), (o), (r), (ra), (s), (t), (u) and (v) of Schedule 5.
